APPROVAL TO COMMENCE THE GENERAL NURSING PROGRAMME AT THE SCHOOL OF NURSING, ARCHBISHOP CHARLES HEEREY MEMORIAL COLLEGE OF NURSING SCIENCES, OGBOR HILL, ABA, ABIA STATE

I wish to inform you that the Board of Nursing and Midwifery Council of Nigeria at its 54th General Meeting approved the establishment of Nursing programme in the College of Nursing Science, Ogbor Hill, Aba, Abia State and awarded it a Provisional Accreditation status with effect from February, 2020. The Board also approved an annual student intake of fifty (50) students.

The Provisional approval is for a period of two (2) years after which the School will be revisited for assessment. The first set of Students will commence their training in May, 2020,

All recommendations made in the report are to be fully implemented by the Management of the College.

The Provost of the College is to forward quarterly progress report to the Council unflinchingly.

Please **NOTE** that the approved fee for establishment of a Nursing training institution is a non-refundable fee of **N2,625,000 (Two Million, Six Hundred and Twenty-five Thousand Naira) only**. This money is to be paid into Council's TSA account with the Central Bank of Nigeria using Remita Platform after generating a ten digit RRR number through any Commercial Bank.
